### Terms and Conditions

Minimum wholesale orders are 1 pallet, which is about 1,000 pounds of fresh bamboo shoots. We accept credit cards, ACH transfers, or Net 10 terms (unless other terms are set) based on approved credit. All delivered sales are FOB acceptance at the shipping point. Under these conditions, a full shipment may not be rejected by the buyer. When notified within 8 hours of a shipment's arrival, any reasonable claims against product that contains abnormal deterioration under normal transportation conditions will be honored by providing a discount to the invoice total. For pickups arranged by the buyer, the truck must be refrigerated and support an environment of 34-36 degrees Fahrenheit/1-2 degrees Celsius. When notified within 24 hours of the shipment's arrival, any reasonable claims against product that contains abnormal deterioration under these transportation conditions will be honored by providing a discount to the invoice total. If only partial or no payment has been received 30 days from the date of delivery, we will charge a 1.5% monthly late fee on the remaining invoice balance. This late fee will repeat monthly for a year or until the new invoice total has been paid in full. If we have had no contact, no payments, or only partial payments from your company by 30<sup>th</sup> day, we will file a complaint against your company through PACA, which could involve an attorney. We (the shipper) will be entitled to collect reasonable attorney's fees and expenses as part of an action to collect on an invoice. Actual attorney's fees incurred in bringing any action to collect on an invoice and/or enforcing any judgment granted and interest shall be considered as additional sums owed in connection with a transaction. Because bamboo shoots are a fresh produce comprised of water, they must be stored at 34-36 degrees Fahrenheit/1-2 Celsius to extend their shelf life or prevent rapid deterioration. We highly recommend moving the product to the end consumer within a week of its arrival.
